WHEREAS, His Excellency President Ferdinand "Bongbong" R. Marcos, Jr. issued Administrative Order No. 03 dated 23 December 2022 authorizing the grant of Gratuity Pay to Contract of Service (COS) and Job Order (JO) workers in Government for Fiscal Year 2022 in the amount not exceeding Five Thousand Pesos (Php 5,000.00);

**WHEREAS**, AO No. 03 states that granting a year-end Gratuity Pay to COS and JO workers is a well-deserved recognition of their hard work in implementing programs, projects, and activities, and pivotal role in the delivery of government services amidst the ongoing COVID-19 pandemic and present socio-economic challenges;
