Referred to the Committee on Senior Citizens and Persons With Disability is the aforementioned subject, present during the Committee Hearing held on March 04, 2024 at exactly 9:00 a.m. in the Sangguniang Panlungsod Session Hall are the Committee Chairman Nestor "Boy" E. Dimacuha, and members Councilors Isidra "Ched" M. Atienza, Jose Jonash Luis F. Tolentino and Lorenzo A. Gamboa, Jr. Also present are the following SP Members: Councilors Nelson J. Chavez, Oliver Z. Macatangay and Armando C. Lazarte. Invited guests who attended the hearing are Josefina E. Dangal-OSCA-Head, Apolonia B. Santoyo-CCE-Board of Director, Bartolome J. Ong-CCE-Board of Director, Cesar S. Ramos-CCE-Board of Director, Elenita E. Cuy-CCE-Board of Director, Avelino N. Collera-CCE-Board of Director, Nikko Sumadsad - Operation Supervisor of SM City Batangas, Virginia C. Clemeno -CCE-Board of Director, Nelson P. Barte-PWD, Hiyasmin A. Candava-CSWDO, Rufina C. The following subjects were discussed:

Since February 7, 2023, by virtue of **RESOLUTION NO. 22-59 S. 2023**, the Memorandum of Agreement (MOA) was enacted upon and reviewed by the Sangguniang Panlungsod members. With regards to the issue on Ordinance which also the subject at hand, it was already enacted in consideration on the requests as stated in the letter and during the discussion in the Committee Hearing, the following are:

- Appropriation of budget by the City to cover its payment of the free cinema admission fee in the absence of a specific provision in the appropriation for the general welfare fund to cover such program;
- Amount to be paid to SMLI after the SC/PWD discount and the discount of SMLI;
- Exemption from amusement tax on the free cinema admission fee to be paid by the City to SMLI;

with the collaboration of all present in the hearing, the proposed possible amendments of the existing Ordinance will be given utmost considerations by the Committee.

Further, while awaiting for the enactment of the proposed amendment of the Ordinance, the SM Management was humbly requested by the Committee to effectively implement the **FREE CINEMA ADMISSION** in consideration to the existing Ordinance and MOA.

Considering the veracity of the report, the following are hereby recommended:

- 1) Adoption of this Committee Report.
- 2) The approval of the proposed amendments to the existing Ordinance No. 18 S. 2012, An Ordinance Granting PWD Free Movie Access to All Movie Theaters in the City of Batangas, to be calendar on the next regular session.
