WHEREAS, Section 455 of the Republic Act No. 7160 also known as the Local Government Code of 1991 explicitly provides that the City Mayor as the Chief Executive of the City Government shall exercise such powers and performs such duties and functions;

WHEREAS, Section 455, paragraph 1, sub-paragraph 6 further provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod;

Referred to the Committee on Laws, Rules and Regulations is the aforementioned subject, present during the Committee Hearing held on March 05, 2024 at exactly 9:00 a.m. in the Sangguniang Panlungsod Session Hall are the Committee Chairman Nestor "Boy" E. Dimacuha, and members Councilors Isidra "Ched" M. Atienza and Nelson J. Chavez. Also present are the following SP Members: Councilors Hamilton G. Blanco, Oliver Z. Macatangay, Lorenzo A. Gamboa, Jr., Michael C. Villena and SK President Marcus Manuel D. Castillo. Invited guests who attended the hearing are Ms. Majorie Marasigan of the Catholic Relief Services (CRS)/Climate Resilient Cities (CRC), Ms. Ms. Sylvia Sueno - CRS, Annadel Sapugay - CRS/Ci, Atty. Jebril Alan Calingasan of the City Legal Office and Architect Cardelan Hernandez of the CPDO.

The following subjects were discussed:

The Catholic Relief Services (CRS) – United States Conference of Catholic Bishops, an non-profit corporation is implementing the USAID-funded five (5)-year Climate Resilient Cities (CRC) project by donating two (2) units of Geographic Information System (GIS) desktop workstations to capacitate the LGU of Batangas City to map, forecast, and model climate informations to strengthen the adaptive capacity of the City to the impacts of climate change and disasters.

Additional legal documents are being required for the swift processing of the Deed of Donation as follows:

- 1) Certificate of Authorization in the form of Special Power of Attorney (SPA) or General Power of Attorney (GPA) to Mr. Jonas H. Tetangco to co-enter into the contract;
- Certificate of Completion and Transfer of Ownership that will signify CRS (Donor) fulfilment of its responsibilities and the commencement of the full ownership and responsibilities of the LGU of Batangas City (Donee) to the use of the donated equipments;
- 3) Input or incorporation of a provision that the Donee's responsibilities will start only upon signing of the Certificate of Completion and Transfer of Ownership.

The revised and final copy of the Deed of Donation together with the required legal documents will be submitted by the Donor within a week.

Considering the veracity of the report, the following are hereby recommended:

- 1) Adoption of this Committee Report.
- 2) Approval of a Resolution authorizing the Honorable City Mayor Beverley Rose A. Dimacuha to execute, enter into and sign a Deed of Donation with the Catholic Relief Services United State Conference of Catholic Bishops.
