WHEREAS, Social Pension for Indigent Senior Citizens is a government assistance mandated under R.A. 9994 otherwise known as “Expanded Senior Citizens Act of 2010”;

WHEREAS, the DSWD, as the lead agency for social protection, is mandated to work towards the achievement of improved capacity and opportunities of the poor, vulnerable, and disadvantaged individuals, families, and communities, to enable them to improve their quality of life;

WHEREAS, to ensure the expeditious delivery of assistance, fund transfer to the City Government of Batangas is identified as a mode of payment to qualified senior citizens;

WHEREAS, there is no legal impediment for the passage of the requested Sangguniang Panlungsod Resolution.

COMMITTEE REPORT

SUBJECT: LETTER FROM THE CITY MAYOR BEVERLEY ROSE A. 
