RESOLUTION AUTHORIZING THE CITY MAYOR BEVERLEY ROSE A. DIMACUHA TO EXECUTE, ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH PCG BATANGAS CITY

WHEREAS, Batangas City and PCG-CGDSTL has long been partners in the enforcement of laws, conduct of maritime security operations, safeguarding of life and property at sea, and the protection of marine environment, wildlife and resources within and along Batangas Bay, City of Batangas, Province of Batangas;

WHEREAS, the herein PARTIES acknowledge that the maintenance of a modern, adequate and accessible headquarters is necessary for the PCG-CGDSTL to continuously carry out its mission within the maritime jurisdiction of Batangas City;

WHEREAS, the PCG-CGDSTL has been granted, accommodated, and allowed use and occupation of its current headquarters, situated at Brgy. Sta. Clara, Batangas City by the BATANGAS CITY;

WHEREAS, a parcel of land where the current headquarters of the PCG-CGDSTL is erected and covered by **Tax Declaration No.0090-01020**, owned by and registered under the name of the City Government of Batangas;
