**A RESOLUTION EXPRESSING THE SANGGUNIANG PANLUNGSOD NG
BATANGAS’ SUPPORT FOR THE CONSTRUCTION OF THE BATANGAS CITY –
IBAAN – ROSARIO LINK ROAD**

WHEREAS, upon the initiative of the Honorable Congressman Mario Vittorio A. Mariño, Representative of the 5th District of Batangas, the Construction of the Batangas City – Ibaan – Rosario Link Road is proposed;

WHEREAS, the approximately 10.4 km. road will connect the 4th and 5th Legislative Districts of Batangas with Batangas City mainland, via the thoroughfares from Star Tollway to Pinamucan Bypass Road in Batangas City to the Ibaan – Rosario Diversion Road;

WHEREAS, the project aims to promote economic growth and development in the areas traversed by the proposed link road, provide easy access to the flow of products and services and promote ease of travel;

NOW THEREFORE, be it resolved, as it hereby resolves in session assembled that the Sangguniang Panlungsod ng Batangas, as represented by its Members, express support and endorsement for the construction of the Batangas City – Ibaan – Rosario Link Road;
