#### **RESOLUTION NO. 22-124 S. 2024**

# A RESOLUTION APPROVING THE ACCREDITATION OF BATANGAS MEDICAL CENTER EMPLOYEES MULTI-PURPOSE COOPERATIVE

WHEREAS, presented before the Sangguniang Panlungsod, were papers of BATANGAS MEDICAL CENTER EMPLOYEES MULTI-PURPOSE COOPERATIVE for accreditation purposes;

WHEREAS, in adherence to the Local Government Code of 1991 as reiterated below, the following provisions were elucidated among the representatives of BATANGAS MEDICAL CENTER EMPLOYEES MULTI-PURPOSE COOPERATIVE during the committee hearing held on March 12, 2024 at Session Hall, Sangguniang Panlungsod, Batangas City that were attended by the members of the said committee and other members of the Council.

- 1. Chapter 4. Relations with People's and Non-governmental Organizations.
  - 1.1 Section 34. Role of People's and Non-governmental Organizations. Local Government Units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy.

## A RESOLUTION APPROVING THE ACCREDITATION OF BATANGAS MEDICAL CENTER EMPLOYEES MULTI-PURPOSE COOPERATIVE

- 1.2 Section 35. Linkages with People's and Non-governmental Organizations. - Local Government Units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.
- 1.3 Section 36. Assistance to People's and Non-governmental Organizations. - A Local Government Unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise for economic, socially-oriented, environmental or cultural projects to be implemented within its territorial jurisdiction.

WHEREAS, the Committee on Accreditation of the Sangguniang Panlungsod has scrutinized the papers of BATANGAS MEDICAL CENTER EMPLOYEES MULTI-PURPOSE COOPERATIVE in order to find out whether this NGO is qualified for accreditation and membership in the Local Special Bodies;

WHEREAS, the Sangguniang Panlungsod thru the Committee on Accreditation has approved the accreditation of BATANGAS MEDICAL CENTER EMPLOYEES MULTI-PURPOSE COOPERATIVE as accredited NGO in the Sangguniang Panlungsod, after having found to have complied with all the necessary requirements for this purpose;

NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled to approve, as it is hereby approved, the application for Accreditation of BATANGAS MEDICAL CENTER EMPLOYEES MULTI-PURPOSE **COOPERATIVE** in the City of Batangas.

RESOLVED FURTHER, that all documents attached hereto made integral part of this resolution and that copy of this resolution be furnished to BATANGAS MEDICAL CENTER EMPLOYEES MULTI-PURPOSE COOPERATIVE for their guidance and information.

The Committee called a Committee Hearing for the purpose of evaluating the qualifications of the applicant for accreditation, and to reiterate the provisions of the Local Government Code and its Implementing Rules and Regulations and to provide other clarificatory guidelines relative to the accreditation of people's organizations, non-governmental organizations and other organized groups, and in the selection of their representatives to the local special bodies.

The Committee held a Committee Hearing on March 12, 2024. Present during the Committee hearing were the Committee Chairman on Accreditation Hon. Nelson J. Chavez and Committee Members: Hon. Ched M. Atienza, Hon. Nestor E. Dimacuha, Hon. Armando C. Lazarte, Hon. Michael C. Villena. Also present were Hon. Andrea Loise F. Macaraig, Hon. Zester Carlo M. Hernandez, Hon. Lorenzo A. Gamboa Jr., ABC President Hon. Angelito A. Dimacuha, Ms. Elvira Gajila — General Manager of BATMC Employee Multi-Purpose Cooperative, Ms. Marichu Sanvictores — President BATMCEMPC and Ms. Jaerel Balahibo — BATMCEMPC office staff.

The committee hearing revolved around the accreditation of people's organization, non-governmental organizations and similar aggrupations, which focused on the coverage, purpose, accreditation process and requirements and other related guidelines. The committee finds that the applicant substantially complied with the requirements of the law for accreditation.
