## COMMITTEE REPORT

Subject: Deed of Donation for Road Lot situated at Brgy. Talumpok Kanluran and Brgy. Tingga Itaas Batangas City.

### **BACKGROUND:**

The subject is requesting for the passage of a resolution authorizing the City Mayor to sign and accept in behalf of the City Government of Batangas the Deed of Donation with Sps. Carlito and Eusebia Suarez, consisting of 578.00 sqm. Parcel of land to serve as road lot, covered by Tax Declaration No. 0100-00269, situated at Talumpok Kanluran, Batangas City and with Terry B. Villarba et. al., consisting of 22.00 sqm. parcel of land to serve as road lot, covered by TCT No. 052-2016001612 situated at Tinga Itaas, Batangas City and was referred to the Committee on Public Lands on March 5, 2024 during the regular session. The Committee held a hearing on March 12, 2024 and in attendance were the following:

The Committee on Public Lands Chairman, Hon. Michael C. Villena, and its members namely, Hon. Hamilton Blanco and Hon. Andrea F. Macaraig. Also present were the Sangguniang Panlungsod Members namely, City Vice Mayor Atty. Alyssa Renee Cruz, and City Councilors: Hon. Karlos Buted, Hon. Nestor Dimacuha, Hon. Oliver Macatangay, Hon. Nelson Chavez, Hon. Armando Lazarte, Hon. Jonash Tolentino, Hon. Zester Hernandez, Hon. Isidra Atienza and Hon. Lorenzo Gamboa Jr.

The guests present were members of the Barangay Council, namely, Barangay Captain Isagani Lontoc from Brgy. Talumpok Kanluran and Brgy. Admin. Lorenzo Pena from Brgy. Tingga Itaas. Also present were the land owners/donors, Mr. Carlito Suarez from Brgy. Talumpok Kanluran and Mr. And Mrs. Honorio Hontiveros, SPA of the Land owners from Brgy. Tingga Itaas.

Also present during the hearing were Atty. Jebril Calingasan Legal Representative from the Office of the City Legal, Arch. Cardelan Hernandez representative from City Planning and Development Office, Engr. Ruel B. Bool, OIC from the Office of the City Assessor, Ms. Arminda Madayag, OIC from the Office of the City Treasurer, Ms. Aster Marasigan, City Internal Audit Service Officer from Internal Audit Service.

#### FINDINGS:

The Chairman of the Committee on Public Lands, the members of the Committee, and the Members of the Sangguniang Panlungsod extensively made an overview of the subject and suggested the necessary matters:

- 1. The Brgy. Chairman Isagani Lontoc of Brgy. Talumpok Kanluran stated that the land serving as barangay road has been repaired and concreted. The land owner/donor still paying the taxes of the land. There are no proper documents that has been settled and pertinent documents must be accomplished before the donation of the property.
- 2. Engr. Ruel Bool stated that the road existing road is being utilized as a barangay road and it operates under restrictions as prescribed by the law.
- 3. Atty. Jebril Calingasan from the City Legal Office recommended that the deed of donation of the road lot must have a proper legal proof and must be coordinated with the Bureau of Internal Revenue (BIR) and public notaries.
- 4. The member of the Committee and the members of the Sangguniang Panlungsod remarked that the donors and the beneficiaries of the land must follow the legal processes being implemented as to donation of land.
- 5. The Sangguniang Panlungsod members also concluded that all documents must be in legal processes, and the lot must be registered immediately in order to have a title; However this is a lesson to those who will donate land in the future that the documents to be passed must be legal.

In conclusion, the necessary and legal documents must be prepared for the adjustment of the subject matter in order for it to be addressed immediately.

#### **RECOMMENDATIONS:**

In view of the foregoing, the Committee hereby recommends:

- 2. The approval of the Resolution hereto attached.
