WHEREAS, pursuant to Section 454 (d) of R.A. 7160, the City Mayor requested the Sangguniang Panlungsod for the concurrence to the appointment of Ms. Aurea R. Castillo as City Government Department Head I in the Office of Human Resource Management and Development;

WHEREAS, the appointment of City Human Resource Management and Development Officer conforms to Section 3 of Civil Service Commission (CSC) Memorandum Circular No. 12, Series 2022 which provides;

Pursuant to Civil Service Commission (CSC) Resolution No. 2200373 promulgated on 20 September 2022, the CSC adopts the 2022 Guidelines and Standards in the Establishment of Organizational Structures and Staffing Patterns (OSSPs) in Local Government Units (LGUs), as follows:

"Pursuant to Section 76 of R.A. No. 7160, the Civil Service Commission (CSC) shall prescribe minimum standards and guidelines in the design and implementation of Organizational Structures and Staffing Patterns (OSSPs) in Local Government Units (LGUs). It provides, as follows:

Section 76. Organizational Structure and Staffing Pattern. – Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission."

It is, therefore, the responsibility of every LGU to design, approve, and implement its Organizational Structures and Staffing Patterns (OSSPs) in accordance with the 2022 Guidelines and Standards in the Establishment of Organizational Structures and Staffing Patterns (OSSPs) in Local Government Units (LGUs)";

WHEREAS, Civil Service Commission (CSC) Memorandum Circular 19 Series of 1992, Guidelines and Standards in the Establishment Organizational Structures and Staffing Patterns in Local Government Units provides that:

"Pursuant to Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Civil Service Commission shall prescribe minimum standards and guidelines in the design and implementation of organizational structures and staffing patterns in Local Government Units. It provides, as follows:

"Section 76. Organizational Structure and Staffing Pattern. - Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission":

WHEREAS, the City Mayor and the Local Finance Committee certify that funds for the said position are available and that the limitation provided for under Section 325 of R.A. 7160 have been considered;

NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to concur as it hereby concurs, with the appointment of Ms. Aurea R.
