# CONFIRMING THE APPOINTMENT OF MS. FLORA C. ALVAREZ AS CITY GOVERNMENT DEPARTMENT HEAD I (CITY AGRICULTURIST) IN THE OFFICE OF THE CITY AGRICULTURE

WHEREAS, pursuant to Section 454 (d) of R.A. 7160, the City Mayor requested the Sangguniang Panlungsod for the concurrence to the appointment of Ms. Flora C. Alvarez as City Government Department Head I (City Agriculturist) in the Office of the City Agriculture;

**WHEREAS**, the appointment of City Agriculturist Officer conforms to Article XII, Section 482 of the Local Government Code of 1991, thus:

"SECTION 482. Qualifications, Powers and Duties. — (a) No person shall be appointed agriculturist unless he is a citizen of the Philippines, a resident of the local government unit concerned, of good moral character, a holder of a college degree in agriculture or any related course from a recognized college or university and a first grade civil service eligible or its equivalent. He must have practiced his profession in agriculture or acquired experience in a related field for at least five (5) years in the case of the provincial or city agriculturist, and three (3) years in the case of the municipal agriculturist.

The position of an agriculturist shall be mandatory for the provincial government and optional for the city government."
