**A RESOLUTION AUTHORIZING THE CITY MAYOR BEVERLEY ROSE A
DIMACUHA TO EXECUTE, ENTER INTO AND SIGN A MEMORANDUM OF
AGREEMENT WITH THE PHILIPPINE COAST GUARD (PCG) BATANGAS CITY
FOR THE CONTINUED USE, OCCUPATION AND POSSESSION OF THE CURRENT
HEADQUARTERS FOR A PERIOD OF THREE (3) YEARS**

WHEREAS, the Philippine Coast Guard (PCG) Batangas City represented by its District Commander, CG Commodore Geronimo B. Tuvilla had been a long-time partner in the enforcement of laws, conduct of maritime security operations, safeguarding of life and property at sea, and the protection of marine environment, wildlife and resources within and along Batangas Bay, City of Batangas, Province of Batangas;

WHEREAS, the maintenance of a modern, adequate and accessible headquarters is necessary for the PCG Batangas City to continuously carry out its mission within the maritime jurisdiction of Batangas City;

WHEREAS, PCG Batangas City headquarters situated at Brgy. Sta. Clara, Batangas City has been accommodated and allowed the use and occupation for many years and has proven to be an essential asset in the enhancement of maritime safety and security within the jurisdiction of Batangas City;

WHEREAS, the PCG Batangas City will continue to become the partner of Batangas City in fulfilling its crucial role in maintaining the maritime security along and within Batangas Bay;


