CONFIRMING THE APPOINTMENT OF ATTY. SONNY JOSE M. RICABLANCA AS CITY GOVERNMENT DEPARTMENT HEAD I (CITY LEGAL OFFICER) IN THE OFFICE OF THE CITY LEGAL

WHEREAS, pursuant to Section 454 (d) of R.A. 7160, the City Mayor requested the Sangguniang Panlungsod for the concurrence to the appointment of Atty. Sonny Jose M. Ricablanca as City Government Department Head I (City Legal Officer) in the Office of the City Legal;

WHEREAS, the appointment of City Legal Officer conforms to Article XI, Section 481 of the Local Government Code of 1991, thus:

"SECTION 481. Qualifications, Terms, Powers and Duties. – (a) No person shall be appointed legal officer unless he is a citizen of the Philippines, a resident of the local government concerned, of good moral character, and a member of the Philippine Bar. He must have practiced his profession for at least five (5) years in the case of the provincial and city legal officer, and three (3) years in the case of the municipal legal officer.

The appointment of legal officer shall be mandatory for the provincial and city governments and optional for the municipal government.

WHEREAS, the City Mayor and the Local Finance Committee certify that funds for the said position are available and that the limitation provided for under Section 325 of R.A. 7160 have been considered;
