**RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN AND ENTER INTO A  
MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-  
TREATMENT AND REHABILITATION CENTER BICUTAN (DOH-TRC BICUTAN)  
FOR THE SUBSTANCE ABUSE PREVENTION PROGRAM FOR BATANGAS CITY  
COMMUNITY-BASED DRUG REHABILITATION PROGRAM**

**WHEREAS**, Section 75 of RA 9165, otherwise known as the “Comprehensive Dangerous Drugs Act of 2022”, the Department of Health was tasked to oversee and monitor the integration, coordination and supervision of all drug rehabilitation, intervention, after-care and follow-up programs, projects and activities as well as the establishment, operations maintenance and management of privately owned drug treatment rehabilitation centers;

**WHEREAS**, under pertinent law of RA 747, the Department of Health may regulate and collect fees to be charged against patients in government and charity clinics proportionate to their financial capacities;

**WHEREAS**, Article VII Section 51 of RA 9165 Local Government Units are required to appropriate a substantial portion of their respective annual budgets to assist in or enhance the enforcement of the said law by giving priority to preventive or educational programs and the rehabilitation or treatment of drug dependents;

**WHEREAS**, the DOH, by virtue of Republic Act No. 747, may regulate and collect fees to be charged against patients in government and charity clinics proportionate to their financial capacities;



## **DISCUSSIONS**

During discussions, the committee scrutinized this Memorandum of Agreement. DOH – TRC Bicutan representative gave a background and overview of the subject. The main objective of the rehabilitation program is to provide the tools, skills and support needed to lead a happy and fulfilling life following illness, injury, and addiction for people who are victims of illegal drugs in the City of Batangas.

It was learned that the above-mentioned subject is for renewal, therefore representative from DOH-TRC Bicutan discussed the expanded services which include in this agreement. Certain paragraphs of Memorandum of Agreement (MOA) specifically on Paragraph I.A (Residential) and Paragraph I.B (delete item no. 5 and re-write item no. 6) are need to consider in order to make this agreement clear and to avoid confusion in the aforementioned subject.

The committee ensures that every suggestions are incorporated to improve further the subject.

## **FINDINGS**

In this hearing, the committee finds the necessity of having the rehabilitation facility for the patients or drug victims who are resident of Batangas City and need to undergo a drug treatment and rehabilitation programs.
