**RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN THE MEMORANDUM
OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND
DEVELOPMENT (DSWD) FOR THE MILK FEEDING PROGRAM (MFP) FOR THE
SCHOOL YEAR 2024-2025**

WHEREAS, the State in its endeavor to address malnutrition among children enacted Republic Act No. 11037 otherwise known as the “Masustansyang Pagkain para sa Batang Pilipino Act of 2018”;

WHEREAS, the program aims to provide essential nutrients to children, ensuring their proper growth and development;

WHEREAS, the DSWD in its mandate to provide social welfare and development programs, particularly through technical assistance and resource augmentation, has been providing community-based nutrition programs and services such as Food for School and Healthy Start Feeding Program in child development centers at the local government units (LGUs); partnership with non-government organizations (NGOs) is employed to promote community participation;

WHEREAS, there is no legal impediment for the passage of the requested Sangguniang Panlungsod Resolution.


