**A RESOLUTION RATIFYING THE PUBLIC FINANCIAL MANAGEMENT
IMPROVEMENT PLAN (PFMIP) FY 2022**

WHEREAS, as stated in the Local Government Code of 1991, it is the policy of the State to ensure that the territorial and political subdivisions of the State to attain their fullest development as self-reliant communities and make them effective partners in the attainment of national goals;

WHEREAS, stated also is that local government units (LGUs) should have an accountable, efficient, and dynamic organizational structure and operating mechanism that will meet the priority needs and service requirements of its communities;

WHEREAS, as stated in the PFMAT Book produced by the Department of Budget and Management, the Public Financial Management Improvement Plan (PFMIP) is an integral part of the LGU as it provides general framework for: (1) generating revenues; (2) allocating resources; and (3) managing expenditures;
