**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET OF  
BARANGAY POBLACION 12, BATANGAS CITY FOR CALENDAR YEAR 2024**

**WHEREAS**, a review of the Supplemental Budget for Calendar Year 2023 of Barangay Poblacion 12, Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

**NOW THEREFORE**, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budget of Barangay Poblacion 12, Batangas City for Calendar Year 2024 for the purpose the amount was appropriated:
