**A RESOLUTION FAVORABLY ENDORSING THE APPLICATION OF ATLANTIC,
GULF AND PACIFIC CORPORATION OF MANILA, INCORPORATED (AG & P CO.,
INC.) TO DEVELOP AND/OR OPERATE 46.002521 HECTARES, MORE OR LESS,
OF LAND LOCATED AT PHASE II SITE OF THE BATANGAS PORT DEVELOPMENT
PROJECT LOCATED IN BARANGAY CALICANTO, BATANGAS CITY AS
SPECIAL ECONOMIC ZONE, SUBJECT TO ALL LEGAL AND
EXISTING RULES AND REGULATIONS**

WHEREAS, pursuant to Republic Act 9710, otherwise known as the Special Economic Zone Act of 1995, private sector initiative is encouraged for the development and establishment of a Special Economic Zone;

WHEREAS, Atlantic, Gulf and Pacific Corporation of Manila, Incorporated (AG & P Co., Inc.) applied for the grant of pre-qualification clearance with the Philippine Economic Zone Authority (PEZA) for the conversion of the 46.002521 hectares of land as special economic zone to be known as AG&P Special Economic Zone II;

WHEREAS, prior to the endorsement to the President of the Philippines of the subject area as Special Economic Zone, alongside with other prerequisites that has already been secured and submitted, the Philippine Economic Zone Authority necessitates a favorable endorsement from the Sangguniang Panlungsod as provided for under Republic Act 7916, as amended;

WHEREAS, the registration of AG&P Co., Inc. as a Special Economic Zone will be most beneficial to the City and its populace for it will generate employment opportunities, provides economic development and promote the general welfare of the people;

WHEREAS, AG&P shall comply with the City Ordinance No. 8 Series of 1994 entitled "An Ordinance Providing Priority in Employment of Work to Qualified Barangay Residents on Business Establishment and Infrastructure Projects Within the Territorial Jurisdiction of the Barangays Within Batangas City and Providing Penalties for Violation Thereof" and the commitment of PEZA in ensuring that future locators of AG&P shall prioritize the employment of qualified residents of Barangay Calicanto and other barangays of Batangas City;

NOW THEREFORE, be it resolved as it hereby resolved by the Sangguniang Panlungsod of Batangas, by virtue of the powers vested in it by law, in session assembled, to favorably endorse the application of Atlantic, Gulf and Pacific Corporation of Manila, Incorporated (AG&P Co., Inc.) with the Philippine Economic Zone Authority (PEZA) to develop and/or operate 46.002521 hectares, more or less, of land located at Phase II Site of the Batangas Port Development project located in Barangay Calicanto, Batangas City as Special Economic Zone;


