**WHEREAS**, the priority programs and projects included in the City Supplemental Annual Investment Program No. 2 for Fiscal Year 2013 are in consonance with the goals and objectives of the Batangas City Comprehensive Development Plan for Calendar Year 2009 – 2018;

**WHEREAS**, the Batangas City Supplemental Annual Investment Program No. 2 for Fiscal Year 2013 includes priority social, economic, environmental, infrastructure and development administration programs, projects and activities which gear towards the realization of the city development vision, thrusts, goals and objectives;

**WHEREAS**, the identified programs and projects included in the Batangas City Supplemental Annual Investment Program No. 2 for Fiscal Year 2013 are in line with the realization of the Eight-Point Agenda of the present administration;
