These annual barangay budgets for CY 2013 are therefore considered operative and effective as of January 1, 2013 in accordance with Section 332 of R.A. 7160.


Certified copy of this resolution shall immediately be furnished to the respective concerned Sangguniang Barangay, through its Punong Barangay, and to the City Budget Officer.
