WHEREAS, the City Mayor Eduardo B. Dimacuha requested for authority to release the amount of P1,000,000.00 from calamity fund to be donated to the provinces of Bohol and Cebu:

WHEREAS, more recently, localities such as Tacloban City, Coron, Palawan and Panay Provinces were devastated by Super Typhoon Yolanda;

WHEREAS, to be able to help more people, the City Government of Batangas determines that the amount of donation be increased from One Million (P1,000,000.00) to Two Million Five Hundred Thousand Pesos (P2,500,000.00) and to donate the said amount to the more needy localities such as Bohol, Tacloban City, Coron, Palawan and Panay Provinces;

WHEREAS, the amount requested by the City Mayor is allowed under Section 21 of RA 10121 and Rule 18 Section 1 of its Implementing Rules and Regulations which states that "upon recommendation of the LDRRMO and approval of the Sanggunian concerned, the LDRRMC may transfer an amount of the LDRRM Fund to support disaster risk reduction work and other LDRRMC's which are declared under state of calamity";
