WHEREAS, as per Section 111 of R.A. 7160, each local development council shall create an executive committee to represent it and act on its behalf when it is not in session;

WHEREAS, the Executive Committee of the City Development Council as per letter b, Section 111 of R.A. 7160 could formulate policies, plans and programs based on the general principles laid down by the council and could act on matters requiring immediate attention or action by the council;

WHEREAS, the Batangas City Supplemental Annual Investment Program No. 3 for Fiscal Year 2013 contains appropriations for City Disaster Risk Reduction and Management Fund and Capital Outlays;

WHEREAS, the proposed programs, projects and activities listed in the City Supplemental Annual Investment Program No. 3 for Fiscal Year 2013 are geared towards the attainment of the city vision, thrusts, goals and objectives;
