RESOLUTION NO. 245 S. 2013

A RESOLUTION REQUESTING THE CITY EXECUTIVE TO REQUIRE THE REVIEW OF THE SPECIAL PERMIT FOR THE OPERATION OF TIANGGE TRADE FAIR

WHEREAS, the Batangas City Government gave Mrs. Marietta Serrano a special permit to operate Tiangge Trade fair at Plaza Mabini, Batangas City from November 29, 2013 to January 19, 2014 with attached conditions;

WHEREAS, the following are the attached conditions of the special permit to operate Tiangge Trade Fair and Plaza Mabini: That the operator shall comply with the requirements of relevant laws, rules and regulations, including but not limited to:

- The rate under Revenue Code, Section 92 Tiangge or Privilege Store
- 2. To clean the area daily
- 3. To maintain the cleanliness of Plaza Mabini Toilets
- Organic/Natural (sasa, sawali and the like) in compliance to the Batangas City E-Code Plastic ban
- 5. Plastic Ban
- Monitoring of BPLO and CENRO for compliance
- All public utilities must be paid by the organizer
- 8. At least 25% of the tenants is from Batangas City Market Stalls
- 9. Occupy only at the designated area/location approved by the City Government
- To provide stalls at their own expenses
- 11. Operation starts from November 29, 2013 up to January 19, 2014 only.

Continuation of Resolution No. 245 S. 2013

A RESOLUTION REQUESTING THE CITY EXECUTIVE TO REQUIRE THE REVIEW OF THE SPECIAL PERMIT FOR THE OPERATION OF TIANGGE TRADE FAIR

WHEREAS, some Batangueños are complaining about the cleanliness of Flaza Mabini toilets and the use of plastic in the Trade Fair area.

WHEREAS, there is a need to comply with the Revenue Regulation No. 16-2013 and Regulation No. 7-2012 for tax collection purposes on income payments of "privilege stores" and the obligations of organizers for the operation of privilege stores.

WHEREAS, there is a need to specify the terms and conditions favorable to the City in special permit issued to organizers like inclusions of demand to organizers such as providing security guards, fire extinguisher, portable toilets and others.

WHEREAS, to reconsider shorten the existence of tiangge for fair competition to our market vendor.

WHEREAS, there is a need to review and revised the special permit for the operation of the Tiangge Trade Fair.

NOW THEREFORE, be it resolved, as it is hereby resolved, by the Sangguniang Panlungsod in session assembled, requesting the City Executive to require the review of the special permit for the operation of Tiangge Trade Fair.
