RESOLUTION NO. 72 S. 2013

AUTHORIZING THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF
AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS
FOR THE IMPLEMENTATION OF PROJECT FUNDED BY THE CY 2012
SPECIAL LOCAL ROAD FUND


WHEREAS, the Department of Public Works and Highways has approved the funding of the Rehabilitation/Improvement of Drainage along D. Silang Street at Barangays Poblacion 18 and 22, Batangas City from the Calendar Year 2012 Special Local Road Fund amounting to P2,219,489.00;

WHEREAS, the City Mayor needs an authority to enter into a Memorandum of Agreement with the Department of Public Works and Highways for the implementation of the project;
