RESOLUTION NO. 84 S. 2013

APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS FOR  
CALENDAR YEAR 2013 OF DIFFERENT BARANGAYS INCLUDING SK BUDGETS

WHEREAS, a review of the Supplemental Budgets of different Barangays including SK Budgets show substantial compliance with the provisions of the Local Government Code of 1991.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the following Barangay Supplemental Budgets and SK Supplemental Budgets for the purposes the amounts were appropriated:

1. Cumba	P 214,397.09
2. Cumba-SK	111,317.80
3. Dumuclay-SK	103,878.00

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.

COMPLIANCE. Compliance to the provisions of the Budget Operations Manual for LGUs issued by the Department of Budget and Management and Commission on Audit and to all auditing rules and regulations are hereby mandated.

EFFECTIVITY. The Supplemental Budgets shall take effect on the date approved by the Sangguniang Barangay or on the date fixed in the Barangay Ordinance as provided in Section 332 LGC and Article 416 IRR.


