**RESOLUTION NO. 88 S. 2013**

**AMENDING RULE V OF THE RULES OF PROCEDURE  
OF THE SANGGUNIANG PANLUNGSOD**

**WHEREAS**, DILG Legal Opinion No. 34 S. 2011 states that the ex-officio member of the Sanggunian should not be considered in the organization/reorganization of the standing committees, as they are to head only the Committee on Barangay Affairs and the Committee on Youth, respectively;

**WHEREAS**, the DILG Legal Opinion above-mentioned accepts an exception that the ex-officio members may be included in the membership of the other standing committees of the sanggunian if the same is provided in the Sangguniang Panlungsod's *Rules of Procedure*;

**WHEREAS**, there is a need to amend Rule V. – The Committees of the Rules of Procedure of the Sangguniang Panlungsod;

**NOW THEREFORE, BE IT RESOLVED**, as it is hereby resolved, by the Sangguniang Panlungsod in session assembled, to amend, as it hereby amends, Rule V of the Rules of Procedure of the Sangguniang Panlungsod, as follows:

Rule V. – The Committees

Section 6. Committee Procedures

- (b) The ex-officio members of the Sangguniang Panlungsod may be considered in the membership of the standing committees of the Sangguniang Panlungsod other than the Committee on Barangay Affairs for ABC President and Committee on Youth for the SK Federation President.




