RESOLUTION NO. 22-09 S. 2023

**RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER AND SIGN INTO
A MEMORANDUM OF AGREEMENT WITH THE CENTER FOR HEALTH
DEVELOPMENT (CHD) 4A-CALABARZON WITH REGARD TO HEALTH
EMERGENCY ALLOWANCE (HEA) TO BE GIVEN TO PUBLIC AND PRIVATE
HEALTH CARE WORKERS AND NON-HEALTH CARE WORKERS**

WHEREAS, Republic Act (RA) No. 11712, known as the Public Health Emergency Benefits and Allowances for Health Care Workers Act and its Implementing Rules and Regulations (IRR) provides for the payment of Health Emergency Allowance (HEA), Sickness and Death Compensation and other benefits for public and private health care workers and non-health care workers during the COVID -19 pandemic and other future public health emergencies with retroactive application starting July 1, 2021;

WHEREAS, Section 5 of the same Act stipulates that the amount of HEA shall vary based on the risk exposure categorization of the Health Care Workers and Non-Health Care Workers in particular setting: Three Thousand Pesos (Php3,000.00) for low risk, Six Thousand Pesos (Php6,000.00) for medium risk and Nine Thousand Pesos (Php9,000.00) for high risk;

WHEREAS, the Department of Health (DOH) Administrative Order (AO) No. 2022-0001 dated January 14, 2022, or the guidelines for COVID-19 Risk Exposure Classification of Health Care Workers, as amended, was issued to set the parameters for determining the risk exposure of personnel in COVID-19 response-involved health facilities;

RESOLUTION AUTHORIZING CITY MAYOR TO ENTER AND SIGN INTO MEMORANDUM OF AGREEMENT WITH THE CENTER FOR HEALTH DEVELOPMENT (CHD) 4A-CALABARZON WITH REGARD TO HEALTH EMERGENCY ALLOWANCE (HEA) TO BE GIVEN TO PUBLIC AND PRIVATE HEALTH CARE WORKERS AND NON-HEALTH CARE WORKERS

WHEREAS, the Department of Health (DOH) issued Administrative Order (AO) No. 2022-0039 dated September 2, 2022, to implement the RA No. 11712 and its IRR, particularly requiring the PARTIES to enter into a Memorandum of Agreement;

NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to authorize as it hereby authorizes the City Mayor to enter into Memorandum of Agreement with the Center of Health Development (CHD) 4A-CALABARZON with regard to Health Emergency Allowance (HEA) to be given to public and private health care workers and non-health care workers.

COMMITTEE REPORT

TO : THE HONORABLE PRESIDING OFFICER AND MEMBERS OF THE SANGGUNIANG PANLUNGSOD

SUBJECT : LETTER FROM CITY MAYOR BEVERLEY ROSE A. DIMACUHA REQUESTING FOR THE GRANT OF AUTHORITY FOR THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE CENTER FOR HEALTH DEVELOPMENT (CHD) 4A-CALABARZON WITH REGARD TO HEALTH EMERGENCY ALLOWANCE (HEA) TO BE GIVEN TO PUBLIC AND PRIVATE HEALTH CARE WORKERS AND NON-HEALTH CARE WORKERS

Referred to the Committee on Health on December 20, 2022, the Committee on Health held a Committee Hearing regarding the above-mentioned subject.

The hearing was held on January 04, 2023, 9:00 in the morning at the Sangguniang Panlungsod Session Hall. Present during the Committee Hearing were the Chairman of the Committee on Health, Honorable Councilor Oliver Z. Macatangay, Coun. Jose Jonash Luis F. Tolentino, Coun. Karlos Emmanjuel A. Buted, Coun. Lorenzo Gamboa Jr. and SK President Marjorie Manalo as members of the committee. Also present during the hearing were Sangguniang Panlungsod Members Coun. Hamilton G. Blanco, and Coun. Nelson J. Chavez. Also in attendance were Mrs. Marites Natividad Fortu from City Health Office, Mr. Manolo Perlada of City Budget Office, Ms. Arminda Madayag of City Treasurer Office and Mrs. Annalyn Faytaren from City Administrator Office.

In this hearing, Mrs. Marites Natividad Fortu gave a background and overview of the subject.

During discussion, the City Budget Officer Mr. Manolo Perlada and City Treasurer Officer Ms. Arminda Madayag states that the budget is funded by national government and deposited into Trust Fund of Batangas City Government. They ensure that this fund will be use for the above-mentioned subject matter.

The committee and Sangguniang Panlungsod Members are grateful to our health workers who shared their duty during the COVID 19 Pandemic to meet the medical needs of our fellow Batangenos despite of the high-risk situation.
