**RESOLUTION APPROVING THE SANGGUNIANG PANLUNGSOD REGULAR
SESSION BE HELD ANYWHERE WITHIN THE JURISDICTION OF THE
CITY OF BATANGAS**

WHEREAS, anytime this month of January 2023, the Renovations and Improvement Activities for the Sangguniang Panlungsod Building and its annexes shall commence, and mobilization of equipment, construction crews, and different materials will be transported;

WHEREAS, Sangguniang Panlungsod Building façade will be temporarily barricaded and installation of blue sheet fence for safety and security reasons will also commence soon;

WHEREAS, during the activities, loud noises and sounds caused by the construction activities inside and outside will be generated and at the same time emit dust particles that are harmful to the health of every Sangguniang Panlungsod Employees;

WHEREAS, the same will cause distraction of the Sangguniang Panlungsod Session and the Committee proceedings held in the Sangguniang Panlungsod Session Hall;

WHEREAS, it is imperative for the Sangguniang Panlungsod Session and Committee Hearings be held anywhere within the city jurisdiction, in consonance to Rule VIII, Section 1 (a) par (2) of the Sangguniang Panlungsod Internal Rules of Procedure.
