BATANGENYO OLDER PERSONS – SOCIAL PENSIONERS

WHEREAS, the Department of Social Welfare and Development, as the lead agency for social protection, is mandated to work towards the achievements of improved capacity and opportunities of the poor, vulnerable and disadvantaged individuals, families and communities, to enable them to improve their quality of life;

WHEREAS, Social Pension for Indigent Senior Citizens (SocPen) is a government assistance mandated under RA 9994 or otherwise known as Expanded Senior Citizens Act of 2010. SocPen is being implemented through the Department of Social Welfare and Development (DSWD) conducting mass gathering for the pay outs;

WHEREAS, the Local Government of Batangas thru Republic Act No. 7160, otherwise known as the “Local Government Code of 1991” are mandated to provide services to vulnerable sectors including welfare of the Senior Citizens;
