WHEREAS, the City Mayor, Beverley Rose A. Dimacuha, requests for Authority to sign the Implementation Management Agreement (IMA) with the Department of Agriculture for the Philippine Rural Development Project (PRDP);

WHEREAS, the Implementation Management Agreement (IMA) is an offshoot of the Memorandum of Understanding (MOU) entered into by the City Government through the City Mayor, and the Department of Agriculture, through USEC Domingo F.
