WHEREAS, in a letter dated February 16, 2023, City Mayor Beverley Rose A. Dimacuha requests to pass a resolution regarding the donation of property to Philippine Science High School, Brgy. Sampaga, Batangas City;

WHEREAS, the City Government of Batangas has a property in its name consisting of One Thousand Three Hundred Sixty-four (1,364) square meters located in Barangay Sampaga, Batangas City and covered by Tax Declaration No. 0075-05596 which is used as school site;

WHEREAS, the City Government of Batangas desires to donate the aforementioned piece of property to Philippine Science High School for its expansion;

WHEREAS, it would be more beneficial to Philippine Science High School if the property will be donated and transferred to the institution;

FINDINGS:

1. The existing lot that Philippine Science High School is situated is a property of Batangas City Government; hence, the lot that is requested to be donated for expansion is also a property of Batangas City Government;
2. The property that shall be donated is for the expansion of PSHS that will be used for the students' dormitory;
3. There are no legal impediments found and the requested lot can be transferred to Philippine Science High School.
