**RESOLUTION ADOPTING THE BATANGAS CITY CAMP COORDINATION  
AND CAMP MANAGEMENT AND INTERNALLY DISPLACED PERSONS  
PROTECTION PLAN**

**WHEREAS**, Republic Act 10121 known as “Philippine Disaster Risk Reduction and Management Act of 2021” provides for the National Disaster Risk Reduction and Management Framework and institutionalizing the National Disaster Risk Reduction and Management Plan;

**WHEREAS**, Camp Coordinating and Management Cluster (CCMC) aims to provide timely and well-coordinated humanitarian assistance and augmentation support in the management of evacuation center;

**WHEREAS**, RA 7160, otherwise known as the “Local Government Code of 1991”, mandated every Local Government Unit to provide immediate basic services such as food, clothing, psycho-social support, and emergency shelter assistance to its constituents/victims of natural and manmade disasters;

**WHEREAS**, there is an urgent appeal from the National Government to all Local Government Units to construct Evacuation Camp Management Centers that will cater to the needs of the victims of disasters, both natural and manmade, including all internally displaced persons;

SUBJECT: ENDORSEMENT FROM CITY MAYOR BEVERLY ROSE A. DIMACUHA RE: BATANGAS CITY CAMP COORDINATION AND CAMP MANAGEMENT AND INTERNALLY DISPLACED PERSONS PROTECTION PLAN.

The letter of the Honorable City Mayor Beverly Rose A. Dimacuha re: Batangas City Camp Coordination and Camp Management and Internally Displaced Persons (IDP) Protection Plan, was referred to the Committee on Social Welfare for consideration during the Sangguniang Panlungsod Regular Session held last February 28, 2023.

A Committee Hearing was conducted on March 21, 2023 and was attended by the Sangguniang Panlungsod Presiding Officer and City Vice Mayor - Atty. Alyssa Renee A. Cruz, Members of the Sangguniang Panlungsod, City Legal Officer - Atty. Shaira Garcia, Assistant CSWD Officer - Mrs. Hiyasmin A. Candava, CSWD Social Welfare Officer III - Mrs. Charity C. Nuñez and CPDO Project Development Officer IV - Mr. Cardelan Hernandez.

The City Social Welfare and Development Office was tasked to lead the Camp Coordination and Management Cluster (CCCM) with the objectives of providing a timely and well-coordinated humanitarian assistance, provides augmentation support to the management of evacuation centers, and to ensure the availability of safe, secured and accessible evacuation centers during emergencies and disasters.

ABC President Hon. Angelito "Dondon" A. Dimacuha suggested to include the City Disaster Risk Management and the City Treasurer in the Management Committee.
