**APPROVING AND DECLARING OPERATIVE THE 2023 SANGGUNIANG  
KABATAAN ANNUAL BUDGETS OF BARANGAYS BILOGO AND STA. CLARA  
BOTH OF BATANGAS CITY**

**WHEREAS**, a judicious review, evaluation and analysis of each of the Sangguniang Kabataan Annual Budgets for CY 2023 submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

**NOW THEREFORE**, be it resolved as it hereby resolves, to approve and declare operative the following Sangguniang Kabataan Annual Budgets for Calendar Year 2023 to wit:

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.
