RESOLUTION NO. 22-172 S. 2023

**A RESOLUTION APPROVING THE ACCREDITATION OF KALIPI WOMEN’S
FEDERATION BATANGAS CITY**

WHEREAS, presented before the Sangguniang Panlungsod, were papers of **KALIPI WOMEN’S FEDERATION BATANGAS CITY** for accreditation purposes;

WHEREAS, in adherence to the Local Government Code of 1991 as reiterated below, the following provisions were elucidated among the representatives of **KALIPI WOMEN’S FEDERATION BATANGAS CITY** during the committee hearing held on April 11, 2023 at Sampaguita Farm, Sampaga, Batangas City that were attended by the members of the said committee and other members of the Council.

1. Chapter 4. - Relations with People's and Non-governmental Organizations.

1.1 Section 34. Role of People's and Non-governmental Organizations. - Local Government Units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy.

1.2 Section 35. Linkages with People's and Non-governmental Organizations. - Local Government Units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and

to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.

- 1.3 Section 36. Assistance to People's and Non-governmental Organizations. - A Local Government Unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise for economic, socially-oriented, environmental or cultural projects to be implemented within its territorial jurisdiction.

WHEREAS, the Committee on Accreditation of the Sangguniang Panlungsod has scrutinized the papers of **KALIPI WOMEN'S FEDERATION BATANGAS CITY** in order to find out whether this NGO is qualified for accreditation and membership in the Local Special Bodies;

WHEREAS, the Sangguniang Panlungsod thru the Committee on Accreditation has approved the accreditation of **KALIPI WOMEN'S FEDERATION BATANGAS CITY** as accredited NGO in the Sangguniang Panlungsod, after having found to have complied with all the necessary requirements for this purpose.

NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled to approve, as it hereby approves, the application for Accreditation of **KALIPI WOMEN'S FEDERATION BATANGAS CITY** in the City of Batangas.

RESOLVED FURTHER, that all documents attached hereto made integral parts of this resolution and that copies of this resolution be furnished to **KALIPI WOMEN'S FEDERATION BATANGAS CITY** for their guidance and information.

COMMITTEE REPORT

TO: **THE HONORABLE VICE MAYOR ATTY. ALYSSA RENEE A. CRUZ &
THE HONORABLE SANGGUNIANG PANLUNGSOD MEMBERS**

SUBJECT: Application for Accreditation of KALUPI Women's Federation Batangas City

The Committee called a Committee Hearing for the purpose of evaluating the qualifications of the applicant for accreditation, and to reiterate the provisions of the Local Government Code and its Implementing Rules and Regulations and to provide other clarificatory guidelines relative to the accreditation of people's organizations, non-governmental organizations and other organized groups, and in the selection of their representatives to the local special bodies.

The Committee held a Committee Hearing on April 11, 2023. Present during the committee hearing were the Chairman of the Committee on Accreditation Coun. Nelson J. Chavez and Committee Members, Coun. Nestor "Boy" Dimacuha and Coun. Ched M. Atienza. Also present were Coun. Jose Jonash F. Tolentino, Coun. Lorenzo A. Gamboa Jr., ABC President Coun. Dondon A. Dimacuha, SK Federation President Marjorie A. Manalo. Kalipi Federation President – Mrs. Zenaida Bagsit, Kalipi Federation Vice President – Mrs. Lorna Palo, Kalipi Federation Secretary – Mrs. Cecile Bayani and Kalipi Federation BOD – Mrs. Leonisa Vargas.

The committee hearing revolved around the accreditation of people's organization, non-governmental organizations and similar aggrupations, which focused on the coverage, purpose, accreditation process and requirements and other related guidelines. The committee finds that the applicant substantially complied with the requirements of the law for accreditation.
