WHEREAS, RA 6969, Section 4.b otherwise known as "Toxic Substances and Hazardous and Nuclear Wastes Control Act of 1990", states that the Department of Environment and Natural Resources shall monitor the importation and disposal of chemical substances and mixtures that present unreasonable risk to health or to the environment in accordance with national policies and commitment;

WHEREAS, Section 2 of RA 9003, the Department of Environment and Natural Resources was tasked to ensure the proper segregation, collection, transport, storage, treatment and disposal of solid wastes through the formulation and adoption of the best environmental practice in ecological waste management;

WHEREAS, the Department of Environment and Natural Resources (DENR) proposed a project and was approved during Calendar Year 2022 budget hearing that will improve the collection of COVID-19 related healthcare wastes from quarantine facilities, testing facilities and vaccination sites located in remote areas including small generators that are not service by Transport, Storage, and Disposal facility;

SUBJECT: LETTER FROM CITY MAYOR BEVERLEY ROSE A. DIMACUHA REGARDING THE REQUEST TO GRANT OF AUTHORITY FOR HER TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENTAL MANAGEMENT BUREAU- CALABARZON REGION IN CONNECTION WITH THE PROJECT FOR THE ASSESSMENT, SUPPLY, DELIVERY AND INSTALLATION OF BRAND-NEW PRELIMINARY DISINFECTION AND STORAGE FACILITIES FOR COLLECTED COVID-19 RELATED WASTE

Referred to the Committee on Health on April 11, 2023, the Committee on Health held a Committee Hearing regarding the above-mentioned subject.

The hearing was held on April 18, 2023, 10:00 in the morning at Sampaguita Farm Sampaga, Batangas City. Present during the Committee Hearing were the Chairman of the Committee on Health, Honorable Councilor Oliver Z. Macatangay, Coun. Jose Jonash Luis F. Tolentino, Coun. Karlos Emmanjuel A. Buted, SK President Marjorie Manalo as members of the committee. Also present during the hearing were Vice Mayor Atty. Alyssa Renee A. Cruz, and Sangguniang Panlungsod Council Members Coun. Hamilton G. Blanco, Coun. Andrea Loise F. Macaraig, Coun. Nestor E. Dimacuha, Coun. Armando C. Lazarte, Coun. Nelson J. Chavez, Coun. Zester Carlo M. Hernandez, Coun. Isidra "Ched" M. Atienza and Coun. Michael C. Villena. Also present Mr. Manolo Perlada from City Budget Office, Mrs. Annalyn Faytaren representative by our City Administrator and Mr. Oliver Gonzales from CENRO.

During the hearing, the committee scrutinized the details in the Memorandum of Agreement. Certain paragraph specifically third paragraph was recommended to be deleted/omitted to avoid inconsistency with the Philippine Constitution Article III Section 1.

After extensive discussion, the committee finds the necessity of having a preliminary disinfection and storage facilities that will improve the collection of COVID 19 related healthcare waste from quarantine and testing facilities and vaccination sites located in remote areas to insure the safety of our community from infectious wastes by choosing a DENR Accredited company. Our CENRO Officer Mr. Oliver Gonzales states that it was funded by the Department of Environmental and Natural Resources (DENR) for the facility and only manpower or personnel was need from the city government to support this project.

Considering the foregoing, the committee recommends the following:
