WHEREAS, Section 458 of the Local Government Code declares that the Sangguniang Panlungsod, as the legislative body of the city, shall review and appropriate funds for the general welfare of the city and its inhabitants;

WHEREAS, as mandated by R.A. 7160 or the Local Government Code of 1991, the City Development Council shall formulate and approve the proposed Batangas City Supplemental Annual Investment Program No. 1 CY 2023;
