RESOLUTION NO. 22-217 S. 2023

**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS OF
BARANGAYS DELA PAZ PULOT ITAAS AND SAN MIGUEL, BOTH OF BATANGAS
CITY FOR CALENDAR YEAR 2023**

WHEREAS, a review of the Supplemental Budgets for Calendar Year 2023 of Barangays Dela Paz Pulot Itaas and San Miguel, both of Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budgets of Barangays Dela Paz Pulot Itaas and San Miguel, both of Batangas City for Calendar Year 2023 for the purpose the amounts were appropriated:

Sangguniang Barangay – Supplemental Budgets – CY 2023

1. Dela Paz Pulot Itaas	Php 54,358.12
2. San Miguel	281,286.81

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.

EFFECTIVITY. The approved Supplemental Budget of different barangays shall take effect upon approval by the Sangguniang Barangay concerned or on the date fixed in the Barangay Ordinance as provided in Article 416 IRR and Section 332 LGC.

Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Barangay, through the Punong Barangay and to the City Budget Officer.
