RESOLUTION NO. 22-235 S. 2023

**A RESOLUTION APPROVING THE BATANGAS CITY LOCAL DEVELOPMENT
INVESTMENT PROGRAM (LDIP) FOR CALENDAR YEAR 2023-2025**

WHEREAS, the Local Development Investment Program (LDIP) is a document that translates the Comprehensive Development Plan (CDP) into a process wherein programs, projects and activities (PPAs) were further defined and prioritized for funding;

WHEREAS, the legal basis of the preparation of the LDIP is discussed in the Joint Memorandum Circular No. 001 Series of 2007 issued by the Department of Interior and Local Government (DILG), National Economic and Development Authority (NEDA), Department of Budget and Management (DBM) and Department of Finance (DOF) which details the Harmonization of Local Planning, Investment Programming, Revenue Administration, Budgeting and Expenditure Management;

WHEREAS, the preparation of the LDIP aims to establish the plan-budget link by rationalizing the process of PPA selection and prioritization through analyzing the city's fiscal status;

WHEREAS, the LDIP shall have a time frame of at least three (3) years or during the three-year (3) term of the elected city officials;


