**GRANTING AUTHORITY TO THE CITY MAYOR BEVERLEY ROSE A. DIMACUHA  
TO ENTER INTO CONTRACT WITH RAZOR BACKS SWIMMING SPORTS CLINIC  
FOR THE CONDUCT OF BASIC SWIMMING AND WATER SURVIVAL TRAINING  
COURSE FOR THE CHILDREN, YOUTH AND PERSONS WITH  
DISABILITIES/IMMEDIATE FAMILY MEMBERS OR GUARDIANS**

**WHEREAS**, according to Joint Memorandum Circular No. 2015-01 on Section 13, Article II of the 1987 Constitution declares that “the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being and shall inculcate in the youth patriotism and nationalism and encourage their involvement in public and civil affairs”;

**WHEREAS**, the City Mayor Beverley Rose A. Dimacuha requested for the grant of authority to enter into contract with Razor Backs Swimming Sports Clinic for the conduct of Basic Swimming and Water Survival Training Course for the Children, Youth and Persons with Disabilities/Immediate Family Members or Guardians;
