FINDINGS:

- The requested resolution is valid and imperative in collecting and managing remittances from South Premiere Power Corporation (SPPC) LNG Plant Facility, and disbursing funds for DLF and RWMHEEF programs and purposes;
- 2. No accounting and auditing rules will be violated as the creation of the two (2) bank accounts promotes proper accounting and better disbursements and prevents duplication of bank accounts.
- 3. The two accounts that will be created will be classified as a special account under the general fund; this is a separate and special account, thus, this will not be mixed in the general fund;
- 4. Disbursements are restricted except for provisions allowed by the Department of Energy (DOF):
- 5. As quarterly remittances are received on the immediately following month, appropriation and allocation on programs must not be forecasted.
- 6. The signatories for the two bank accounts that will be opened were named as City Mayor Hon. Beverley Rose A. Dimacuha, City Treasurer Ms. Arminda L. Madayag, and City Administrator Engr. Januario B. Godoy
