**WHEREAS**, Section 17 of Republic Act No.7160, otherwise known as the Local Government Code of 1991, provides that local government units shall provide basic services and facilities including the establishment of school buildings;

**WHEREAS**, in a letter dated June 15, 2023, Mrs. Ethel M. Lualhati, Principal IV of Gulod Elementary School, requested for the conversion of Gulod Elementary School to Gulod Integrated School to be implemented this SY 2023-2024;

**WHEREAS**, the Sangguniang Panlungsod firmly believes that establishing a learning institution adheres to youth well-being and nation building;


