**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS  
FOR CALENDAR YEAR 2023 OF BARANGAYS PAHARANG SILANGAN AND  
STA. RITA APLAYA, BOTH OF BATANGAS CITY**

**WHEREAS**, a review of the Supplemental Budgets for Calendar Year 2023 of Barangays Paharang Silangan and Sta. Rita Aplaya, both of Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;
