**A RESOLUTION SUPPORTING THE CONVERSION OF TALAHIB PANDAYAN
NATIONAL HIGH SCHOOL INTO AN INTEGRATED SCHOOL TO BE NAMED AS
TALAHIB PANDAYAN INTEGRATED HIGH SCHOOL**

WHEREAS, as stated in Article XIV Section 1 of the Philippine Constitution, the State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all;

WHEREAS, Section 17 of Republic Act No.7160, otherwise known as the Local Government Code of 1991, provides that local government units shall provide basic services and facilities including the establishment of school buildings;

WHEREAS, Mrs. Annalyn Eborra, Principal of Talahib National High School, requested for the conversion of Talahib Pandayan National School to Talahib Pandayan Integrated High School to be implemented this SY 2023-2024;

WHEREAS, the Sangguniang Panlungsod firmly believes that conversion of the above-mentioned school promotes youth well-being and nation building;

WHEREAS, the request is in line with the establishment of the school and a requirement of the Department of Education Region IV-A;
