KABATAAN SUPPLEMENTAL BUDGETS OF BARANGAYS MAAPAZ, STO.  
DOMINGO AND STA. RITA KARSADA, ALL OF BATANGAS CITY**

**WHEREAS**, a judicious review, evaluation and analysis of each of the Sangguniang Kabataan Supplemental Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

**NOW THEREFORE**, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets for the purpose the amounts were appropriated:
