**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET OF
DIFFERENT BARANGAYS OF BATANGAS CITY FOR CALENDAR YEAR 2023**

WHEREAS, a review of the Supplemental Budget for Calendar Year 2023 of different Barangays shows substantial compliance with the provisions of the Local Government Code of 1991;
