A RESOLUTION COMMENDING THE ELECTRONIC BUSINESS ONE-STOP SHOP (eBOSS) UNDER BUSINESS PERMITS AND LICENSING OFFICE (BPLO) OF THE CITY GOVERNMENT OF BATANGAS AND ALL OF ITS EMPLOYEES FOR HAVING BEEN CONFERRED THE CERTIFICATE OF COMMENDATION FOR ITS IMPLEMENTATION IN THE RECENTLY CONDUCTED ONLINE VALIDATION OF eBOSS BY THE ANTI-RED TAPE AUTHORITY (ARTA)

WHEREAS, Republic Act 11032 or otherwise known as "Ease of Doing Business and Efficient Government Service Delivery of 2018" established the Anti-Red Tape Authority (ARTA), is an attached agency of the Office of the President that is tasked to oversee and implement the national policy on ease of doing business and anti-red tape in the Philippines;

WHEREAS, an inspection was conducted pursuant to the mandate of ARTA to audit and validate the Electronic Business One-Stop Shop (eBOSS) of the City Government of Batangas as provided for in Republic Act No. 11032;

WHEREAS, on July 21, 2023, Secretary Ernesto V. Perez, Director General of ARTA from the Office of the President, has conferred an award of Certificate of Commendation to eBOSS Implementation of the City Government of Batangas;

WHEREAS, the City Government of Batangas was the first City in the Southern Luzon Region accorded with an award by the ARTA for the compliance with the requirements of Section 11 (c) of R.A.
