WHEREAS, in a letter dated September 6, 2023, PCPT Jan Danao Ricote, Officer-in-Charge of 403 Maneuver Company, Regional Mobile Force Battalion 4A, requested for the passage of a resolution denouncing atrocities committed by the Communist Party of the Philippines, New People's Army and National Democratic Front (CPP/NPA/NDF) within the jurisdiction of Batangas City;
