- If possible, employees who continuously serve for the Batangas City Government for over 30 years shall be prioritized. Hence, they shall be entitled to social services compensation, or other improvised ways to address their concerns.
- 3. Employees, especially those who have not yet taken the Civil Service Exam, shall be guided to take the CSE for their eligibility and promotion.
- 4. According to Ms. Castillo of the HRMDO, deliberation of employees is done every two months per department/division.
