REQUEST OF THE CITY MAYOR FOR AUTHORITY TO SIGN A MEMORANDUM  
OF AGREEMENT (MOA) WITH THE SECURITY BANK FOUNDATION, INC., AND  
ABS-CBN FOUNDATION FOR CERTAIN DONATIONS TO THE BATANGAS CITY  
GOVERNMENT AND FOR THE PASSAGE OF AN ORDINANCE EXEMPTING
