WHEREAS, PD 957 is passed to closely supervise and regulate real estate practitioners, owners and developers in the Philippines, which primary purpose is to protect buyer's welfare from all types of real estate misrepresentations;

WHEREAS, the unauthorized and illegal conduct of "Subdigayat" activities in various Barangays in Batangas City has been observed;

WHEREAS, said activities were being conducted without proper permits, licenses and compliance with necessary requirements such as Certificate of Registration and other prescribed requirements from the Department of Human Settlement and Urban Development (DHSUD), License to Sell and Site Development Permit;

WHEREAS, it is the duty and responsibility of the Local Government and the Sangguniang Panlungsod to ensure the proper implementation and enforcement of laws and regulations within its jurisdiction;

## **DISCUSSIONS AND OBSERVATIONS**

The following observations resulted after extensive discussions and deliberations of all present during the Committee hearing, to wit:

1. The committee advised the developers to secure the following documents:

Certificate of Registration and other prescribed requirements from the Department of Human Settlement and Urban Development (DHSUD)

➤ License to Sell

➤ Site Development Permit

2. The right protocol was explained to the developers in order to comply with the requirements.

3. Determine the classification of the property to be developed if it is compliant with the

Comprehensive Land Use Plan of Batangas City.

- 4. The Resolution of No Objection issued by the Barangay was usually vague and lack of specifics. In order a Resolution to be legally binding which is stipulated in Local Government Code Section 33, all undertakings in Barangay must be discussed and put into a Memorandum of Agreement such as Corporate Social Responsibility (CSR) to protect the interest of the Barangay.
- 5. The developers will be given a copy of the Ordinance No. 20, S. 2018 (An Ordinance Establishing Sewage and Septage Management for the City of Batangas).

## **RECOMMENDATIONS**

In accordance with the proceedings and based on the observations and discussions during the Committee Hearing, the Committee proposes the following recommendations:

- Urges all Barangay Captains, residents and stakeholders to report any observed illegal "subdigayat" activities and subsequently discontinue the selling and developing without necessary permits;
- 2. The City Planning and Development Office must continuously conduct the site inspection monitoring for the proposed and on-going "subdigayat" activities;

3. The adoption of this Committee report and;

4. The approval of the Resolution hereto attached.
