**APPROVING AND DECLARING OPERATIVE THE 2024 ANNUAL BUDGETS OF  
BARANGAYS BALAGTAS AND MARUCLAP, BOTH OF BATANGAS CITY**

**WHEREAS**, a judicious review, evaluation and analysis of each of the Barangay Annual Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

**NOW THEREFORE**, be it resolved as it hereby resolves, to approve and declare operative the following Annual Barangay Budgets for Calendar Year 2024 to wit:

The budget documents shall form part of the authorized barangay budget.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.
